America's political crisis has reached a breaking point. Extremism, corruption, and gridlock have led to a destabilizing and dangerous 'system failure' that stymies progress on nearly every issue. While our politics spiral out of control, the US is falling behind other nations in education, health, incarceration rates, debt... the list goes on. Commonsense solutions exist, but they are off-limits to politicians trapped within the failing system.

RepresentUs was founded in 2012 to pass anti-corruption laws that fix the root cause of this crisis. We are leading a movement of independents, progressives, and conservatives that builds on America's long tradition of pursuing federal reform through the states. In 2018, twenty-three transformative anti-corruption laws—from anti-gerrymandering and ranked choice voting to sweeping ethics and transparency reforms—were passed in cities and states: more than in any other year in our nation's history.

And while we're heartened by these victories, we are clear-eyed about the challenges ahead: The cost of elections continues to skyrocket. Seething polarization is turning neighbors into enemies. Government is paralyzed by gridlock and corruption. We cannot depend on politicians to fix the problem, nor can we wait for a natural course correction.

The time is now. We must fix our political system. Here's how we'll do it, together.

THE PROBLEM

America's laws are no longer determined by civil discourse, evidence-based policymaking, or the will of the people. Instead, they're written by and for special-interest groups, political extremists, and the biggest spenders.

CORRUPTION

Special interests wield undue influence in virtually all levels of government. Transparency and ethics laws are weakened and routinely circumvented, allowing the biggest spenders and political insiders to run the show behind closed doors.

EXTREMISM

Broken election laws promote political extremism and gridlock. They incentivize our leaders not to compromise, even though most Americans want them to advance public-interest outcomes.

LACK OF COMPETITION

Gerrymandering and our "winner-take-all" voting system deprive voters of real choices and accurate representation. A lack of competition and new ideas reinforces voters' apathy and cynicism about politics.

THE SOLUTION

We're building a movement of Americans across the political spectrum to pass and protect anti-corruption laws that are both impactful and politically viable.

FIX BROKEN ELECTIONS

Americans deserve an election system that matches our nation's historic commitment to democratic values. We're working to:

END GERRYMANDERING so no political party gains an unfair advantage at the voters' expense.

ENACT RANKED CHOICE VOTING so voters can choose the candidates they like best without helping elect those they like least.

IMPLEMENT AUTOMATIC VOTER REGISTRATION & VOTE FROM HOME

so more people can securely participate and voters don't have to stand in line on Election Day. Instead, they can make informed voting choices from home.

FIGHT CORRUPTION

By implementing strong ethics laws and creating a campaign finance system that increases the power of small-dollar donors, we ensure politicians represent their constituents, rather than special interests. We lead and support campaigns for policies that:

CHANGE HOW ELECTIONS ARE FUNDED

to increase the power of small-dollar donors, so their voices aren't drowned out by big money.

CLOSE THE REVOLVING DOOR so politicians can't sell their votes for the promise of future lucrative jobs.

END POLITICAL BRIBERY by banning lobbyist gifts and donations to politicians.

A PROVEN STRATEGY

Our grassroots, state-and-local political strategy has worked throughout American history. A Bloomberg News study looking at women's right to vote, marriage equality, prohibition, and other issues concluded that throughout US history, "a key event—often a court decision or a grassroots campaign reaching maturity triggers a rush of state activity that ultimately leads to a change in federal law."

It's not about how you feel about these issues. It's about learning from their success.

With each victory, we:

CLEAN UP STATE AND LOCAL POLITICS

We transform structural incentives, restoring integrity and disrupting the establishment.

PROVE THAT CHANGE IS POSSIBLE

We show a cynical public and press that fixing the political system isn't just possible—it's happening now. This newfound hope is attracting the support of millions of Americans.

CHANGE CONGRESS

Election law is determined by the states, so election reforms directly fix how politicians are elected in that state, including federal races. In just a few election cycles, our reforms will have a gamechanging effect on Congress and the White House, in addition to fixing state politics.

WHAT WE DO

1) LEAD CAMPAIGNS

In some places, we lead local and state campaigns lobbying or ballot initiatives—to pass and protect anti-corruption laws. When we don't lead, we support campaigns with highimpact potential through our Campaign Hub.

2) SUPPORT CAMPAIGNS 3) BUILD THE MOVEMENT

We have 800,000 members; the largest social media assets in the reform field; and an A-list team of Hollywood, academic, and corporate leaders. We annually convene Unrig Summit.

CAMPAIGN HUB

Anti-corruption campaigns have recently emerged in cities and states across the country. Most need significant support—and not just money. In response, we launched the "Campaign Hub" in 2018. It provides six essential assets to these campaigns:

1) GRASSROOTS ENGAGEMENT
2) MODERATE & CONSERVATIVE SUPPORT
3) POLICY DESIGN & POLITICAL STRATEGY
4) CELEBRITY ENGAGEMENT
5) CREATIVE DIGITAL MEDIA & AMPLIFICATION
6) HITTING BACK AGAINST OPPOSITION

UNRIG SUMMIT

In 2018, we brought 1,500 people from all 50 states together to supercharge the national anti-corruption movement. Unrig Summit is the movement's biggest convening, with a focus on solutions, not problems. Political reformers from the right and left put country over party to celebrate their victories and create the next round of reform campaigns.

Unrig 2018 presenters included Jennifer Lawrence, Professors Lawrence Lessig and Michael Porter, Former State Senator Nina Turner, and US Representatives Mike Gallagher (R-WI) and Tulsi Gabbard (D-HI).

MEET THE BADASS GRANDMAS

Dina Butcher (a Republican) and Ellen Chaffee (an Independent), two self-styled "Badass Grandmas," joined forces in North Dakota to win the strongest transparency law in America. North Dakota was one of only seven states without an ethics commission, famous for its lack of transparency and accountability.

RepresentUs members Dina and Ellen led a right-left coalition to pass the North Dakota Anti-Corruption Amendment, which bans gifts from lobbyists to politicians, creates an independent and nonpartisan ethics commission, and closes the revolving door between government and the lobbying industry.



THE MAN TAKING ON CORRUPTION IN ARIZONA

In Arizona, PACs can spend millions of dollars in secret. Represent Phoenix Chapter Leader Carl Parrish worked closely with a local coalition to pass Proposition 419 in Phoenix in November 2018.

The measure, modeled after a successful campaign finance measure that passed in Tempe, AZ, requires any person or group to disclose the true sources of any campaign donations they receive valued at more than \$1,000—a victory for campaign finance reform.
